For homes requesting a logo for marketing purposes but have not completed the GreenPoint Rated process, the Builder and

- A. Builder has a demonstrable and successful commitment to green building.
- B. Builder has engaged the professional services of a certified GreenPoint Rater ("Rater").
- C. Rater or Builder has paid the \$400 initial application fee to Build It Green.
- D. Rater has submitted the Initial Application Materials (Data Collection Form, Energy report, and Debris Recovery Plan) to
- E. Builder has participated in a meeting with the GreenPoint Rater to review the criteria necessary to meet all of the intended measures selected in the Planning Scoresheet tab of the submitted Data Collection Form.
- F. Builder has included the GreenPoint checklist on the drawings, as an Addendum to the drawings or an Architects Supplemental Instructions (ASI).
- G. Builder has or will have conducted a pre-construction team meeting with the GreenPoint Rater, subcontractors and other project construction parties.
- H. All use of the GreenPoint Rated program logo and name shall conform to Build It Green's most current, published GreenPoint Rated Logo Style Guidelines.
- I. All Project marketing collateral bearing the GreenPoint Rated program name shall:
